Entry Payment:

By **check or money order** (US funds, written to CAPER) or by **Zelle** (to secretary@caper-dogs.com). These methods have no extra fee. One check or Zelle payment is sufficient for all your dogs' entries.

By **PayPal or credit card** at caper-dogs.com, PayPal/Credit Card link. Please send a separate payment for the total of each dog's entries. **Payment must include \$2 per class additional charge for the entries to be valid.**

Entries must be received by 6pm CST Wednesday, February 11 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is preferred) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry pended; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via Zelle, PayPal, certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature. **Entries received without signature release will be returned.**

Entries with email addresses will be acknowledged with an email receipt. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be emailed after closing.

Refunds: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Show Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee make it impossible to open or complete the show/trial. Refunds for bitches in season in obedience or rally will be refunded less \$5/entry if notice is made to the trial secretary no later than 30 minutes prior to the start of judging of that sport.

Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 per dog will not be refunded.

Transfers to higher levels: Transfers are available to dogs which, according to their owner's records, have completed the requirements to advance to a higher level after the closing date, in any offered sport. Each of these transfer requests must be made to, and accepted by, the Show/ Trial Secretary at least 30 minutes prior to the start of judging for which the transfer is requested.

HOTEL RULES & CONDITIONS FOR DOG SHOWS

- The dog(s) must pose no threat to guests or hotel associates.
- All guests will provide kennels appropriate to the number of dogs per room.
- Dogs will not be loose within guest rooms unless accompanied by a human.
- A onetime non-refundable pet fee of \$90 will be charged upon check in for up to six dogs per room for duration of reservation.
- Should any issues arise with unattended dogs; the Hotel will address said issue(s) with the Show Chair to handle immediately.
- In the event where your pet causes damage to your room (either during the event or after check out) the Hotel reserves the right to charge the occupant's credit card on file. An SCA Bench Show Committee may be called for room damages.
- Hotel housekeeping must have access to room a minimum of every other day. If housekeeping is not allowed the show committee and hotel management will be notified. The hotel guest will be asked if they agree to an inspection of their room. If SCA guest refuses inspection, they may be subject to a Bench Show Committee. Guest will be accompanied by a member of the SCA Board, show committee representative, and hotel management to inspect the room in question. This is to ensure that the hotel and show committee are made aware of any potential issues with regard to condition of hotel room.
- Dog(s) must be on leash at all times when in public areas, hallways or grounds of the hotel.
- Excessive noise complaints will be addressed by Show Committee and Hotel management to reach a workable, realistic solution to eliminate future disturbances. In the event where a refund is issued to the complainant, the Hotel reserves the right to charge occupant's credit card for refunded charges.
- Dog friendly areas are available directly outside the hotel (lawn areas).
- No dog waste should be deposited in guest room wastebaskets. It is the responsibility of the guests to deposit dog waste in designated waste stations.
- Please do not give your dog a bath in the bathtub in your room. A designated area has been set aside specifically for SCA for bathing dogs. Should a bathtub drain in your room become clogged due to dog hair, a \$300 fee will be assessed.

Just a reminder that our events immediately following the Kentuckian Cluster. This may be an advantage for our exhibitors to compete in events typically held with the Cluster. These may include Conformation, Obedience, Rally, FastCAT, Barn Hunt, Dock Diving and several Health Clinics. The Cluster runs Thursday, March 12th through Sunday, March 15th. Check out the Cluster's Premium List on Infodog.com for full details.

GROOMING & ELECTRICITY – All Grooming reservations (Preferred and General) must be made through the SCA Store.

Attention Members: We are required to cover all grooming areas with plastic. We will need volunteers to help with this task to expedite the readiness of the grooming areas.

Grooming areas be available the evening of Sunday, March 15th as soon as areas are ready – time will be announced.

Electricity will be accessed through wall outlets and shared with nearby exhibitors. Exhibitors are REQUIRED to provide extension cords and circuit breakers.

Preferred Grooming available by paid reservation only. Preferred grooming area will be within the ballroom separated from the ring area by a partial wall. Spaces are pre-assigned and will not be changed. Currently, all preferred grooming spaces have been reserved. A wait list is available on the website and if any cancellations are received the person on the wait list will be notified in the order the request was received.

General Free Grooming – Available on First Come First Served Basis. Total Maximum Spaces 25.

Grooming Spaces will be outside of Show Room.

Maximum of Two 6'x 8' grooming spaces reserved per person. If you want 2 spaces just select space and add to cart twice prior to completion.

Note to exhibitors:

- There is to be no grooming or bathing of dogs in the sleeping rooms per SCA's contract with the Hotel. Hotel will charge name on reservation \$300 for drains blocked due to dog hair. Outside bathing area (access to cold water only) will be provided.
- If you plan to leave dogs unattended in your setup, a phone number that you can be reached at must be visibly posted in your setup in case of emergency.
- No dogs are to remain in the ballroom overnight.
- Exhibitors and handlers will be responsible for clean conditions in the grooming area around their crates. Clean up supplies will be made available if needed.

CLEAN-UP IS YOUR RESPONSIBILITY

If your dog soils the parking lot or show grounds, it is your responsibility to clean up after it. By signing the entry form at this show you are agreeing that all clean-up is your responsibility.

Violators may be subject to an event committee hearing. Exhibitors, please, if you see an area that has not been cleaned up, notify a show official immediately. Thank you.

Exhibitors and handlers will be responsible for clean conditions in and around their crates and are expected to comply with all Club rules as laid out and enforced by the SCA. Damage to hotel or show grounds property will be subject to Show Committee Hearing and action.

Classes divided by sex. Entrants may be altered. Winners eligible to compete for Best of Breed.
8 yrs & under 10 yrs • 10 yrs & under 12 yrs • 12 years & over

Award of Merit: At the judge's discretion, up to 5 dogs/bitches who have competed in the Best of Breed judging may be selected to receive an Award of Merit after BOB, BOS, BOW and Selects are awarded.

Best Puppy, Best Bred By Exhibitor, Best Veteran: 6-9 & 9-12 Puppy class winners will compete for Best Puppy. BBE Puppy & Adult class winners will compete for Best BBE. Veteran class winners will compete for Best Veteran.

National Specialty Reserve Winners Dog & Bitch will receive 3 championship points if the total entry in each sex is at least twice the number of entries needed for a 5 point major.

Non-Regular Classes (multiple dog entries)

Winners of these classes are not eligible to compete for Best of Breed. Altered dogs may be entered.

Stud Dogs Brood Bitches

Dogs/Bitches shown with two of their offspring.

Class is judged on the merits of the offspring, but the parent will be examined for DQs/excuses.

Offspring must be entered in a regular conformation class.

Entry is made for the Stud Dog or Brood Bitch - offspring are not entered on the entry form.

Brace Class

For two dogs, regardless of sex, performing in unison and presented by one handler.

Both dogs in each Brace must have at least one common owner.

Entrants need not be entered in any other class, but each must be on a separate entry form.

JUNIOR SHOWMANSHIP

Novice class: For junior handlers aged 9-17 who, at the time entries close, have not won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

Open class: For junior handlers aged 9-17 who, at the time entries close, have won three first place awards, with competition present, in a Junior Showmanship Novice class at a licensed or member show.

Master class: For junior handlers aged 9-17 who, at the time entries close, have 10 first place wins in an Open class with competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.

Dogs shown in Junior Showmanship may have Full or Limited AKC registration or have an ILP/PAL number. Altered animals are eligible to be shown, but bitches in season are not eligible.

SWEEPSTAKES

Puppy Sweepstakes

Puppy Sweepstakes is open to all Schipperkes who are 6 months but less than 18 months old on the day of the sweepstakes. Dogs must also be entered in one of the 2026 National Specialty regular classes at the regular entry fee. Classes are divided by sex.

6 mos & under 9 mos • 9 mos & under 12 mos • 12 mos & under 18 mos

Veteran Sweepstakes

Veteran Sweepstakes is open to all Schipperkes who are at least 8 years of age on the day of the Sweepstakes. Entrants may be altered and need not be entered in a regular class. Classes are divided by sex.

8 yrs & under 10 yrs • 10 yrs & under 12 yrs • 12 years & over

DISTRIBUTION OF SWEEPSTAKES PRIZE MONEY (both Sweepstakes)

35% of total entry fees will be retained by Club for expenses.

The remaining 65% (for each Sweepstakes) will be awarded as follows:

Best in Sweepstakes 10% of total Sweepstakes entry

Best of Opposite Sex in Sweepstakes 5% of total Sweepstakes entry

Placements receive a percentage of the remaining entry fees of the class entered:

First Place - 40% • Second Place - 30% • Third Place - 20% • Fourth Place - 10%.

All cash prizes rounded to nearest dollar amount. Undistributed funds revert back to SCA.

Indicate the Sweepstakes Class, with age division, in the space provided for Additional Classes on the entry form. Champions of record are eligible to compete.

FUTURITY

The purpose of the Futurity is to encourage the breeding of the best possible Schipperkes and to reward the breeders for their efforts. Prize monies are therefore divided between the owners and the breeders. Detailed nomination instructions are provided in each SCA Bulletin or may be obtained by contacting: Marsha Shafer: ramarschips@embarqmail.com • 509-760-5264

The Futurity stake is for any properly nominated and entered Schipperke that is at least six months old and less than 18 months old on the date of the Futurity competition. They MUST be entered in one of the Regular Classes in the National Specialty show.

Indicate the Futurity class, with age division, in the space provided for Additional Classes on the entry form. Champions of record are eligible to compete. Classes are divided by sex

6 mos & under 9 mos • 9 mos & under 12 mos • 12 mos & under 18 mos

MATURITY

The Maturity is designed to be educational and a complement to the Futurity. By bringing back the previous Futurity nominees and showcasing them as adults, breeders will have the opportunity to see not only how individual dogs have developed, but also how particular bloodlines grow and mature. The Maturity is for adult dogs that came from nominated litters. They need not have been shown in the Futurity, but must have been part of a Futurity nominated litter. Entrants need not be entered in the regular classes and may be altered.

Best in Maturity winners will not be eligible to compete in future Maturity events.

Indicate the Maturity class, with age division, in the space provided for Additional Classes on the entry form.

Maturity Challenge Classes - open to all qualified dogs and bitches that were Futurity eligible the immediately preceding National Specialty to eight years old. Classes divided by sex.

Maturity Class 1 - Dogs and bitches that were Futurity eligible the immediately preceding National Specialty & under four years old on the date of the event.

Maturity Class 2 - Dogs and bitches that are four years old & under six years old on the date of the event.

Maturity Class 3 - Dogs and bitches that are six years old & under eight years old on the date of the event.

DISTRIBUTION OF FUTURITY/MATURITY PRIZE MONEY

All monies from nominations and entry fees (less 35% withheld for SCA expenses) will be divided as follows: Best in Futurity/Maturity 15% Owner of Sire of Best in Futurity/Maturity 5% Best of Opposite Sex 5% Breeder of Best in Futurity/Maturity 15%

Class monies will be divided: First 40%, Second 30%, Third 20%, Fourth 10%

Undistributed funds revert back to SCA.

FOUR-TO-SIX MONTH BEGINNER PUPPY COMPETITION

The Beginner Puppy competition shall be for Schipperkes that are 4 months of age but under 6 months on the day of the event. An AKC registration number or litter number will be required for each entry. A foreign born dog may enter this class if they are registered in the country of origin.

- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete for awards in this class, but must be handled by a non-professional handler. Dogs may not be exhibited by current assistants and household members of a professional handler. Professional handlers are defined as any person who belongs/has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last 5 years.
- All entries must be received by the closing date. No entries will be taken at ringside.

OBEDIENCE & RALLY

Two trials for each type of competition, to be held back to back with start times offset by one hour. Trial 1 is associated with Parent Club Show 1. Trial 2 will be considered the National Specialty trial for each sport.

Refunds for bitches in season will be refunded less \$5/entry if notice is made to the trial secretary no later than 30 minutes prior to the start of judging.

Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

* Professional handlers are not permitted to exhibit in this competition. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay, or received payment for handling a dog.

Master class: For junior handlers aged 9-17 who, at the time entries close, have won the 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

PLEASE NOTE: Juniors must include their AKC Junior Handler number on the entry blank. Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form.
